Learning Loss - Summer Academy

a. Description of Need ([count] of 1000 maximum characters used)

Throughout the COVID-19 Pandemic, staff and students have used untraditional means to access learning. This change has resulted in learning loss for students.

b. Funding Sources

c. Identify qualitative and quantitative data sources used to determine the need(s)([count] of 1000 maximum characters used)

In the absence of state-wide NJSLA testing, school districts have used internal measures of student learning loss. Hamburg School has utilized three core assessment areas. DRAs, NWEA MAPs (reading, language usage, math & science), and grade level benchmark assessments were all used to gauge student learning loss. An analysis of these data points have resulted in both district-wide and individual student learning loss.

d. Root Cause(s) of selected need(s)([count] of 1000 maximum characters used)

The use of remote learning to protect student, staff and community health & safety is the root cause of student learning loss. While this option has allowed students to continue to access their education, the effectiveness of this mode of delivery is secondary to the traditional, in person style of learning.

The COVID-19 Pandemic has brought the effectiveness of HVAC systems to the forefront. Hamburg School's HVAC system as areas that are aging and not as effective as newer options.

The effects of the pandemic have impacted staff and students in multiple ways. As means of supporting school staff, students, and our parent community we have found a need for a guidance counselor to focus specifically on the social emotional support of our stakeholders.

A staff survey reported similar needs with added components of exhaustion and needs to reconnect with colleagues within the school setting. An SEL counselor will organize activities and provide the supports as requested.
