- That the Commissioner of Education stated that not all students need to go to college and there are many trade/apprentice job opportunities for students with high school degrees.
- That Robotics were represented by 409 districts and there is a referendum on the ballot to build technical/vocational schools to train student for job opportunities.
- That a health care update was given but there is uncertainty for 2019/2020 for health costs.
- That the PARCC Test will be reduced from six hours to four hours with other options for students.

- That Teacher Evaluations will count for five percent of teacher evaluations
- That there may be a possible consolidation and regionalization of school districts.
- That the Janus Decision was explained It states that a staff member can opt out of the union/association.

ANNUAL VIOLENCE AND VANDALISM HEARING FOR THE 2017-2018 School Year

The week of October 15-19, 2018 is Violence Awareness in New Jersey schools. As part of our obligation to prevent violence in schools, this report details the activities that were conducted during the 2017-2018 school year and those planned for this academic year.

- The Peer Leadership Group provides mentoring and tutoring services and act as role-models for children under the leadership of the school guidance counselor, Mrs. Braccioforte.
- 2. The entire middle school attended the Center for Prevention's Anti-Bullying Summit on October 18, 2017. Each year, all students in grades 6-8 from Hamburg School participate in presentations and activities that identify violent or bullying behaviors and learn ways to put an end to and prevent violence and bullying in our school. Again this year, all students in grade 6-8 will be attending the Summit on Wednesday, October 19, 2018 at Sparta High School.
- 3. The New Jersey Child Assault Prevention (CAP) program will hold discussions with students on bullying and anti-bullying measures. During the 17-18 school year, students in grades 3, 5 and 7 participated in the CAP program in March.
- 4. The Health curriculum that is covered each year addresses bullying and violence on several levels.
- 5. During the week of October 2-6, 2017, Hamburg students participated in the New Jersey's Seventh Annual Week of Respect during which special attention and class lessons were given to reinforce the importance of being respectful to each other, themselves and anyone with whom they interact both in school and in their community. Student and staff were encouraged to participate in wearing different colors on certain school days to show unity and commitment in preventing bullying. Middle school students also had the opportunity to 'stompout' bullying by popping balloons which contained positive messages. Students

participated in Week of Respect activities during the week of October 1-5, 2018 this school year.

- 6. Red Ribbon week activities to reinforce staying drug free were conducted during the month of November.
- 7. The Hamburg PTA provides assembly programs which support positive messages about being kind towards others and preventing bullying.
- 8. Materials received from the New Jersey Bar Association are implemented during instruction and provide teachers with guidelines on conflict resolution, respect for others and peer mediation.
- 9. Law enforcement is invited into the school to provide school safety and antiviolence discussions to students.
- 10. The school culture and climate committee meets regularly throughout the school year to discuss the positive activities that take place at Hamburg School and plan activities to enhance the educational experience.
- 11. Hamburg Pride assemblies are held throughout each year and focus on themes of respect, trustworthiness, responsibility, fairness, caring and citizenship, the six pillars of good character.

Violence, Vandalism and Substance Abuse

As per Public Law 6A:16-5.3, each school district shall report incidents of violence, vandalism and substance abuse two times per year. Those incidents shall also be reported to the NJ Department of Education via the department's Electronic Violence and Vandalism Reporting System (EVVRS).

As reported to the Department of Education for the second reporting period of January 1, 2018 through June 30, 2018 of the 2017-2018 school year, there were (0) incidents of violence or vandalism which rose to the standards established by the Department of Education.

Harassment, Intimidation and Bullying

As per Public Law N.J.S.A.18A:7E-3, each school district shall report incidents of harassment, intimidation or bullying two times per year.

As reported to the Board of Education at their meetings from February 2018 through July 2018 there were two (2) confirmed instances of harassment, intimidation and bullying reported to Andrea DiFabrizio, School HIB Specialist, and/or Kimberly Sigman, the District HIB Coordinator. Through investigation it was determined that each instance of harassment, intimidation or bullying was confirmed. The accused were disciplined in accordance with

Hamburg Board of Education Policy 5600 Student Discipline/Code of Conduct. The victims and accused also received counseling and sensitivity/awareness training.

As reported to the Department of Education, there were two (2) incidents of harassment, intimidation or bullying during the 2017-2018 school year for the time period of January 1, 2018 through June 30, 2018.
