BOARD SECRETARY'S REPORT

The Business Administrator reported recent changes in the law [effective 1 July 2019] that increased the mileage reimbursement from \$.31 to \$.35 per mile for traveling by personal automobile on official school business and the increase of the minimum wage to \$8.45 to \$10.00 per hour.
