On motion by Mr. Gillen, seconded by Mrs. Frayko, and carried by the following roll call vote, approved payment request # 5, as submitted by Echelon Services, Inc. for the Cafeteria HVAC Project at the Hamburg School, in the amount of \$14,095.63 [DOCUMENT D-1].

On motion by Mr. Gillen, seconded by Mrs. Frayko, and carried by the following roll call vote, approved the FY 2020-21 purchases to be made from the approved low bid vendors utilizing the Educational Data Services, Inc./West/Central New Jersey Cooperative Bidding Program with the Morris County Educational Services Commission as lead agency, with the bid pricing being firm until 30 November 2020.

The Board Secretary discussed the Special Education Medicaid Incentive (SEMI) waiver process. Once the New Jersey Department of Education releases the projected FY 2020-21 student count, a SEMI waiver letter will be sent to the Sussex County Department of Education and the SEMI waiver resolution will be on the agenda of the 18 February 2020 Board meeting.

Note: There is a break in the document #'s due to not receiving the projected student count FY 2020-21 from the New Jersey Department of Education.
