### **Remote Learning**

- Teaching staff continue to prepare lesson packets in hard copy that are distributed to students and made available for parent pick up at the school
- Instructional practices are differentiated to meet student needs, whereas, teaching staff engage in daily communicative instruction (via Zoom, Google Meet, and Class DoJo) with modification supports as indicated in the student's IEP
- Students are asked to hand in assignments for review and grading using the class instructional platform
- Some activities include internet-based assignments; however, completion is contingent on internet connectivity at home; alternative assignments are provided to students if needed
- Pre-K Grade 2
  - ✓ Students are instructionally engaged daily with certified teaching staff via a BOE approved instructional platform
  - ✓ Teaching staff monitor progress of student work daily
  - ✓ Teaching staff are available to support individual student needs and connect with the student/parent via grade specific delivery platform
  - ✓ Hard copy materials are made available (upon request) for parent pick up
  - ✓ Special education modifications, including alternative assignments/modifications in varied format, are provided as warranted.
  - ✓ Parental communication and participation is ongoing on a daily basis
- Grade 3-5
  - ✓ Students are instructionally engaged daily with certified teaching staff via a BOE approved instructional platform
  - ✓ Teaching staff monitor progress of student work daily

- ✓ Teaching staff are available to support individual student needs and connect with the students via grade specific delivery platform
- ✓ Hard copy materials are made available (upon request) for parent pick up
- Special education modifications, including alternative assignments in varied format, are provided as warranted.
- ✓ Parental communication is ongoing on a daily basis
- ✓ Instructional staff continue to monitor and support any changes in connectivity

### • Grades 6-8

- ✓ Students are instructionally engaged daily with certified teaching staff via a BOE approved instructional platform
- ✓ Access to login credentials for all online learning portals has been provided to students and parents for ease of access
- ✓ Students who experience lack of device issues are provided a school issued Chromebook for instructional use
- ✓ Teaching staff monitor progress of student work daily
- ✓ Teaching staff assign individual student support times to meet the needs of all learners
- Students meet individually with teachers weekly to assess their learning and ongoing grading of assignments
- ✓ Parental communication is ongoing on a daily basis
- ✓ Instructional staff continue to monitor and support any changes in connectivity

### **Students**

- Student attendance is based on instructional engagement, assignment completeness, and via teacher daily attendance procedures
- Lack of participation is handled through supportive administrative phone calls to parents
- The office staff also monitor student absences daily via call in procedures for ill students
- Student attendance is documented in the school Student Information System
- Grading continues to be handled in the same manner as prior to school closure
- Assignments are due upon completion with soft timelines
- All 2019-2020 extracurricular activities and field trips have been cancelled as a result of a pandemic outbreak
- Special education modifications, including alternative assignments in varied format, are provided as warranted.
- The school's guidance counselor and psychologist support students through the delivery

of social/emotional supports

- Hamburg School will offer the extended year program remotely from July 6-30 on Mondays through Thursdays from 8:30 AM – 11:00 PM. The ESY program is designed to meet the individual needs as specifically as possible.
- Grade 8 Graduation ceremony is planned as a pre-recorded ceremony to be shared with the community via remote platform on June 18<sup>th</sup> @ 6 PM

### <u>Staff</u>

- Staff utilize a sign in procedure established by Administration via a Google document provided daily
- If a staff member falls ill, the administration will serve as instructor for that given grade/content area until the staff member is able to assume instructional duties
- Staff are engaged in weekly support group meetings with administration where the focus is on technology/subscription needs, hard copy materials distributions, and social/emotional support
- Special education and Special Services staff keep logs of date/time that connections are made with special education students and parents
- Detailed logs are kept to note all related services being provided to students and meetings held with parents
- All staff connectivity logs are provided to administration for review

### **Nutritional Services**

- School meals are delivered with scheduled student/family pick up dates that occur every Monday and Wednesday
- Meal (breakfast/lunch) pick up has been made available to all Hamburg School students
- Pick up dates are: May 4, 6, 11, 13, 18, 20, 27 and June 1, 3, 8, 10, 15, 17
- Pick up location is the Middle School entrance to Hamburg School (30 Linwood Avenue Hamburg, NJ 07419)
- A need to provide survey is posted on the school's website for parents/guardians to indicate number of lunches needed
- Nutritional services are provided to students pre-qualified to receive free or reduced lunch accommodations. McKinney-Vento eligible students will receive nutritional services.

### New Jersey Department of Education Checklist for School Health-Related Closure Plans (Updated 5.4.20)

On March 16, 2020, Governor Phil Murphy signed Executive Order No. 104 (EO 104), implementing aggressive social distancing measures to mitigate further spread of COVID-19 in New Jersey. Among other directives, Governor Murphy's Executive Order indefinitely closed all public, private, and parochial preschools and elementary and secondary schools to students beginning on March 18, 2020. Executive Order No. 107, signed on March 21, 2020, superseded EO 104 and continued the necessary closure of all schools. As detailed in guidance issued by the New Jersey Department of Education (NJDOE) on March 5, 2020 and supplementary guidance issued on March 13, 2020, in order to count days during this closure period toward the statutory requirement to provide public school facilities for 180 days, school districts, charter schools, renaissance school projects and Approved Private Schools for Students with Disabilities (APSSD) were required to develop school health-related closure preparedness plans. These plans were designed to address continuity of critical school services such as remote instruction, special education and related services, and nutrition benefits. As a guidepost for districts in developing remote instruction plans, the NJDOE cited its regulations regarding home instruction due to a temporary or chronic health condition (N.J.A.C. 6A:16-10.1).

# Requirement to Update the District, Charter, Renaissance and APSSD Public Health-Related School Closure Plan as of May 4, 2020

On May 4, 2020, Governor Murphy announced that all New Jersey school buildings would remain closed for in-person instruction for the remainder of school year 2019-2020. Private schools with longer academic years will remain closed until at least June 30, 2020. To ensure that New Jersey students continue to receive high quality, standards-based instruction through the end of the school year, and to provide appropriate transparency, each school district, charter school, renaissance school project and APSSD **must update and post to its website its school health-related closure preparedness plan**. Pursuant to P.L. 2020, c.27, the revised plans must be approved by the district board of education or board of trustees.
