<u>State & County School Boards</u> – Mr. Jones discussed the Hamburg Board of Education's attendance at the Sussex County School Board's monthly meeting and asked for the Board members to rotate attendance.

<u>Sussex County Educational Services Commission</u> – Mr. Jones reported that the Sussex County Educational Services Commission's meeting have been virtual all summer.

Liaison with the Hamburg Borough Council - No report.

<u>Building & Grounds</u> – Mr. Gillen reported that the foam roof warranty holder (Carlisle Roofing) has agreed to provide the materials for the roof repairs and has authorized Hygrade Roofing from Phillipsburg to do the repair work (the Board will pay for the labor); the gym roof work is completed and the closeout paperwork is being compiled; and the New Jersey Department of Education is reviewing the project applications for the Camera System and the Direct Install Energy Upgrade projects.

Education & Policy -

On motion by Mr. Gillen, seconded by Mr. Dreifus, and carried unanimously by roll call vote, after some discussion, approved the second reading of the Policy 1648 (Restart and Recovery Plan) as depicted on [DOCUMENT D].

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried unanimously by roll call vote, approved the first reading of the following policies and regulations as depicted on [DOCUMENT E]:

Negotiations & Personnel -

On motion by Mr. Dreifus, seconded by Mrs. Zicarelli, and carried unanimously by roll call vote, approved Pamela Blauvelt as Grade 4 maternity leave replacement teacher from 30 September 2020 through 5 February 2021 at Step BA1 (\$59,440.00 pro-rated). This position is eligible for benefits.

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried unanimously by roll call vote, accepted the resignation from Heather McDevitt, classroom aide effective 31 August 2020.

On motion by Mr. Gillen, seconded by Mr. Dreifus, and carried unanimously by roll call vote, after some discussion, approved Heather McDevitt as Special Education maternity leave replacement teacher from 1 September 2020 through 2 October 2020 at Step BA 1 (59,440.00 pro-rated). This position is not eligible for health benefits.

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried unanimously by roll call vote, approved a medical leave of absence for employee #89082958 beginning 2 September 2020 through 17 December 2020.

On motion by Mr. Gillen, seconded by Mr. Dreifus, and carried unanimously by roll call vote, approved Jason Havel as custodial substitute for the 2020-2021 school year at a rate of \$14.50 per hour, not to exceed 29.5 hours per week.

On motion by Mr. Gillen, seconded by Mr. Dreifus, and carried unanimously by roll call vote, approved that up to 4 unused personal days for the 2019-2020 academic year be allowed to accumulate and shall take the status of unused sick days in the following year for the Hamburg Education Association staff as a non-precedent setting practice.

A brief discussion occurred on the revised FY 2020-21 State Aid that was recently released. It was noted that the Hamburg Borough BOE did not have a reduction in FY 2020-21 State Aid that the FY 2020-21 budget was built upon.

Mrs. Kimberly Sigman did a presentation of the proposed Hamburg School Restart and Recovery Plan.

On motion by Mr. Gillen, seconded by Mr. Dreifus, and carried unanimously by roll call vote, as per the Superintendent's recommendation, after some discussion, approved the Staff Member ID # 12092261 to increase step on salary guide from BA5 (\$64,450) to MA5 (\$67,770).

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried by the following roll call vote, as per the Superintendent's recommendation, after some discussion, approved [revised instruction contracts for the following:

- Student #9230033251 to attend Northern Hills Academy beginning 3 September 2020 at a cost of \$49,850.00 for the 2020-2021 school year.
- Student #9230033251 for paraprofessional services while attending Northern Hills Academy beginning 3 September 2020 at a cost of \$26,853.00 for the 2020-2021 school year.

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried by the following roll call vote, as per the Superintendent's recommendation, after some discussion, approved [revised instruction contracts for the following:

- Student #9230033251 to attend Northern Hills Academy for the 2020 extended school year at a cost of \$9,727.00 as per student IEP.
- Student # 9230033251 for paraprofessional services while attending Northern Hills Academy for the 2020 extended school year at a cost of \$5,291.00 as per the student IEP.

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried by the following roll call vote, as per the Superintendent's recommendation, after some discussion, approved/accepted the following district goals as depicted on [DOCUMENT H]:

- Goal #1: Hamburg School will continue to collaborate with the school districts in its region to align and further develop curricular programs and shared curricular vision.
- Goal#2: Hamburg School will develop, administer, and evaluate a comprehensive climate survey of parents, staff, and community. Topics should include, but are not limited to: communication, security, curriculum, and technology.
- Goal #3: Hamburg School will implement and maintain a professional development academy of opportunities to support online learning for students, parents and staff.

On motion by Mr. Dreifus, seconded by Mrs. Zicarelli, and carried unanimously by roll call vote, as per the Superintendent's recommendation, after some discussion, approved the combined Professional Development/Field Trip/Facility Use as depicted on [DOCUMENT I].

Mrs. Kimberly Sigman reported as per **[DOCUMENT J]** from Dr. Rosalie Lamonte, the Hamburg School will be closed for in-person instruction on Tuesday, November 3, 2020. Instruction will be delivered to all students via remote learning on that day. Patent-teacher conferences will be held in the afternoon and evening hours. Some discussion ensued.

As of 25 August 2020, student enrollment is 265 with 45 remote learning (17%).

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried by the following roll call vote, as per the Superintendent's recommendation, approved Shared Services Agreement between Franklin Board of Education and the Hamburg Board of Education for the purpose of utilizing school nursing services in emergent situations as depicted on [DOCUMENT K].

Mrs. Kimberly Sigman reported Personal Protective Equipment, a thermal scan, sneeze guards for secretarial stations, desk shields, and additional sneeze guards are in place throughout the school.

There was some discussion on Hamburg School enrollment and Sussex County Charter School enrollment.

On motion by Mr. Gillen, seconded by Mr. Dreifus, and carried by the following roll call vote, as per the Superintendent's recommendation, accepted, with regret, he resignation of Alexandra Backle, paraprofessional, effective 24 August 2020.
