State & County School Boards - Mr. Conklin had no report.

<u>Sussex County Educational Services Commission</u> – Mr. Jones reported that the Northern Hills Academy school building was closed for two weeks due to COVID 19, with staff and students working remotely.

Liaison with the Hamburg Borough Council - No report.

Building & Grounds -

The Board Secretary reviewed the Health Monitoring/Main Entry Vestibule Project timeline [DOCUMENT C].

The Board Secretary discussed the potential of the Referendum Project Bid Timelines not lining up with the Board's 2022 meeting schedule and may require Special Meetings to be scheduled. For example, the Board Secretary reviewed the Restroom timeline and Exterior Repair Project timeline. Some discussion ensued.

January 25, 2022

The Board Secretary reviewed the scope of work for the 1900's Building Mason repairs (repairing various masonry joints in between the bricks and the white concrete collars.

Two issues were discussed:

- 1. To determine if the masonry chimneys for the 1900's Building were going to be repointed in the current exterior repair work or be removed when the 1900's Building's roof is to be done (as per the referendum schedule, this is scheduled for 22/23).
- 2. To determine the decision making process for these referendum projects.

Considerable Board discussion ensued.

On motion by Mr. Gillen, seconded by Mrs. Schels, and carried unanimously by roll call vote, authorized the Administration to make decisions for all the Referendum Projects, as allowed by law and for the Administration to report these major decisions to the Board for the Referendum Construction Projects.

On motion by Mr. Gillen, seconded by Mrs. Zicarelli, and carried unanimously by roll call vote, approved the 1900's building chimneys not to be repointed under the Exterior Repair Project and to remove the chimneys when the 1900's building roof is replaced (scheduled for 2023).

The Board Secretary updated the Board on the Boiler Replacement Project, the Preschool Playground Project and the Exterior Refrigerator/Freezer Projects.

The Board Secretary updated the Board on the investing of the \$4.2 Million bond sale proceeds with Lakeland Bank at a floating rate of 85% of the Federal Funds rate. As of 14 January 2022, the Federal Funds rate is .25%, which translates into a rate of .21% [The New Jersey Cash Management Fund's rate was .05% as of the end of December 2021].
