## **FY 2023-24 BUDGET ADOPTION**

Mr. Dreifus, Chairperson of the Finance Committee summarized the 2 March 2023 committee meeting where the proposed FY 2023-24 Budget was discussed. Mrs. Sigman and the Board Secretary reviewed some of the financial highlights of the proposed FY 2023-24 budget, stating the proposed budget is increasing the General Fund Tax Levy by 4.96% over the prior year's General Fund Tax Levy. Additionally, the proposed 2023-24 budget includes 'other capital projects' for the upgrade to the Hamburg Elementary School's burglar alarm system, a new gym curtain/divider and a storage building. These projects are being funded by the Board's Capital Reserve Account and/or Preschool Education Aid funds. Additionally, the Board is applying to

use Preschool Education Aid funds to defray the cost of a "trike-track" around the existing playground and the newly installed Preschool playground.
